Obligations in Grant Agreement in English (Art. 38)



“This **project** has received funding from the European Research Council (ERC) under the European Union’s [Seventh Framework Programme (FP7-2007-2013)] or [Horizon 2020 research and innovation programme] (Grant agreement No. [number])”

Or

“This **result/equipment/video** is part of a project that has received funding from the European Research Council (ERC) under the European Union’s [Seventh Framework Programme (FP7-2007-2013)] or [Horizon 2020 research and innovation programme] (Grant agreement No. [number])”





Medmindre organet anmoder om eller accepterer noget andet, eller medmindre det er umuligt, skal alt kommunikationsmateriale, som vedrører projektet (også i elektronisk form, via de sociale medier osv.) eller infrastrukturer, udstyr og store resultater, der finansieres af tilskuddet, indeholde

(a) EU-symbolet og EFR-logoet

(b) følgende tekst:

Hvad angår kommunikationsinitiativer: "Dette projekt har modtaget tilskud fra Det Europæiske Forskningsråd (EFR) under Den Europæiske Unions Horisont 2020-program for forskning og innovation med tilskudsafalenummer [nummer]".
