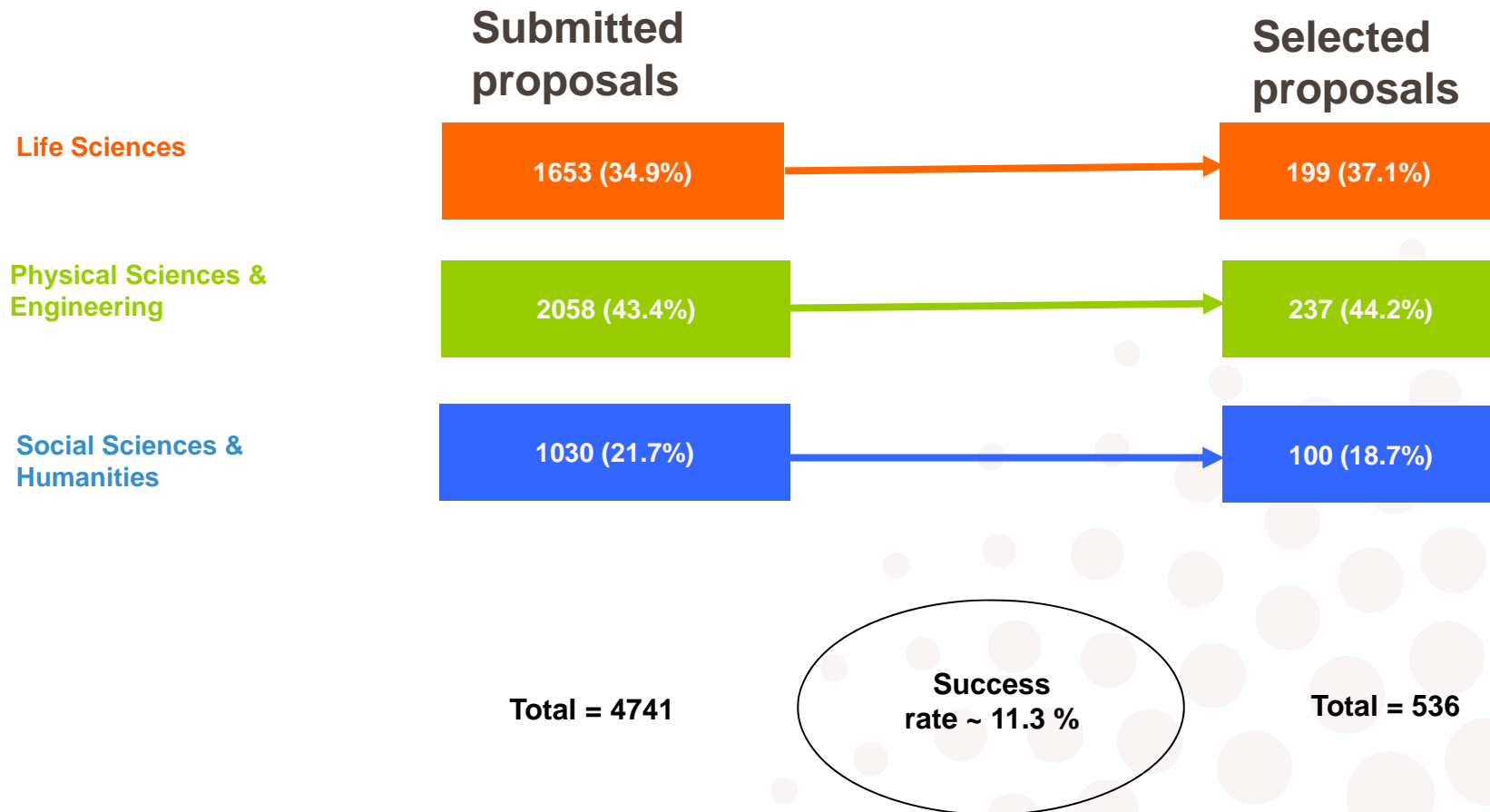

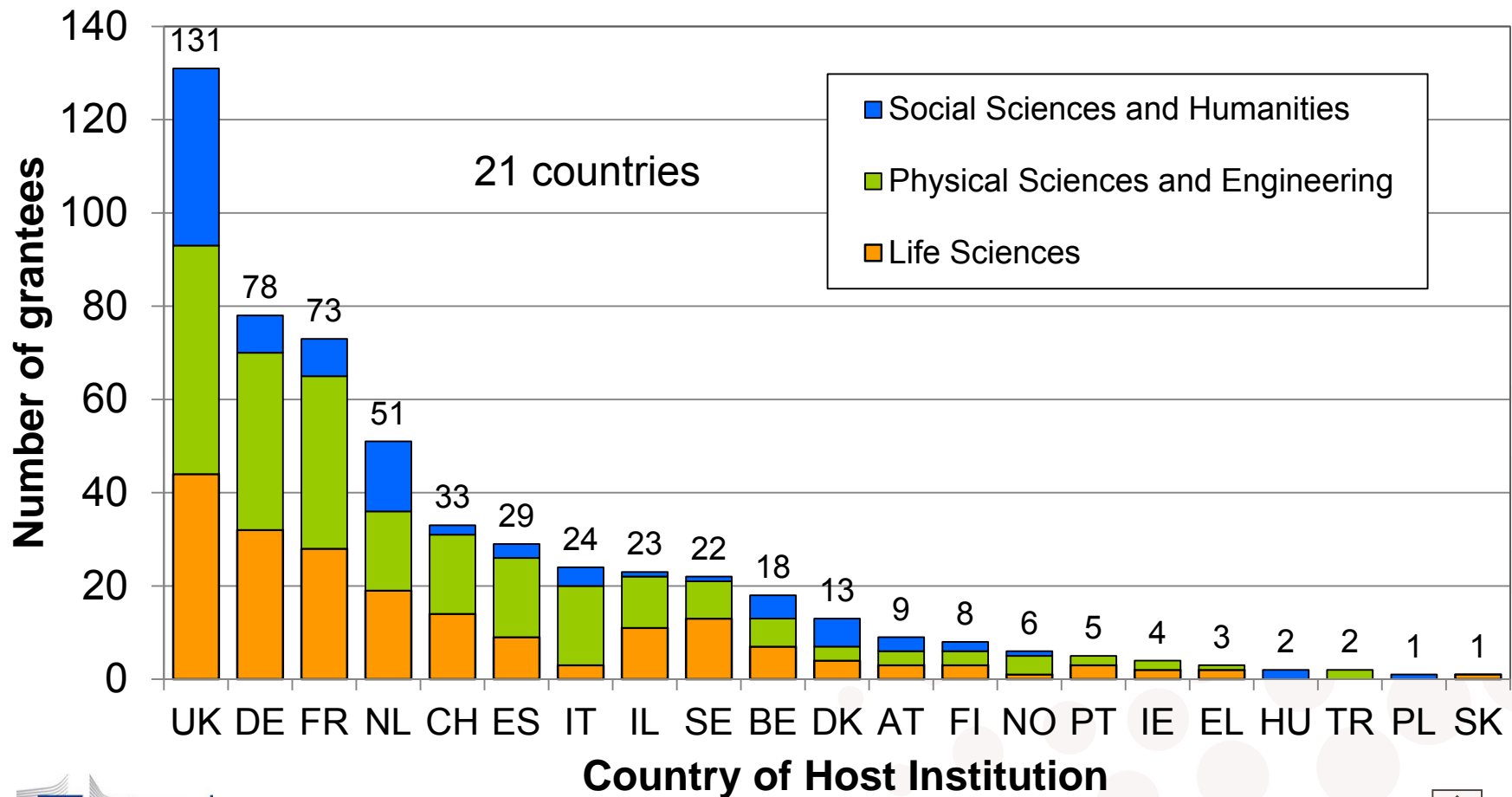
Submitted and selected proposals by domain

Grantees by country of Host Institution & domain

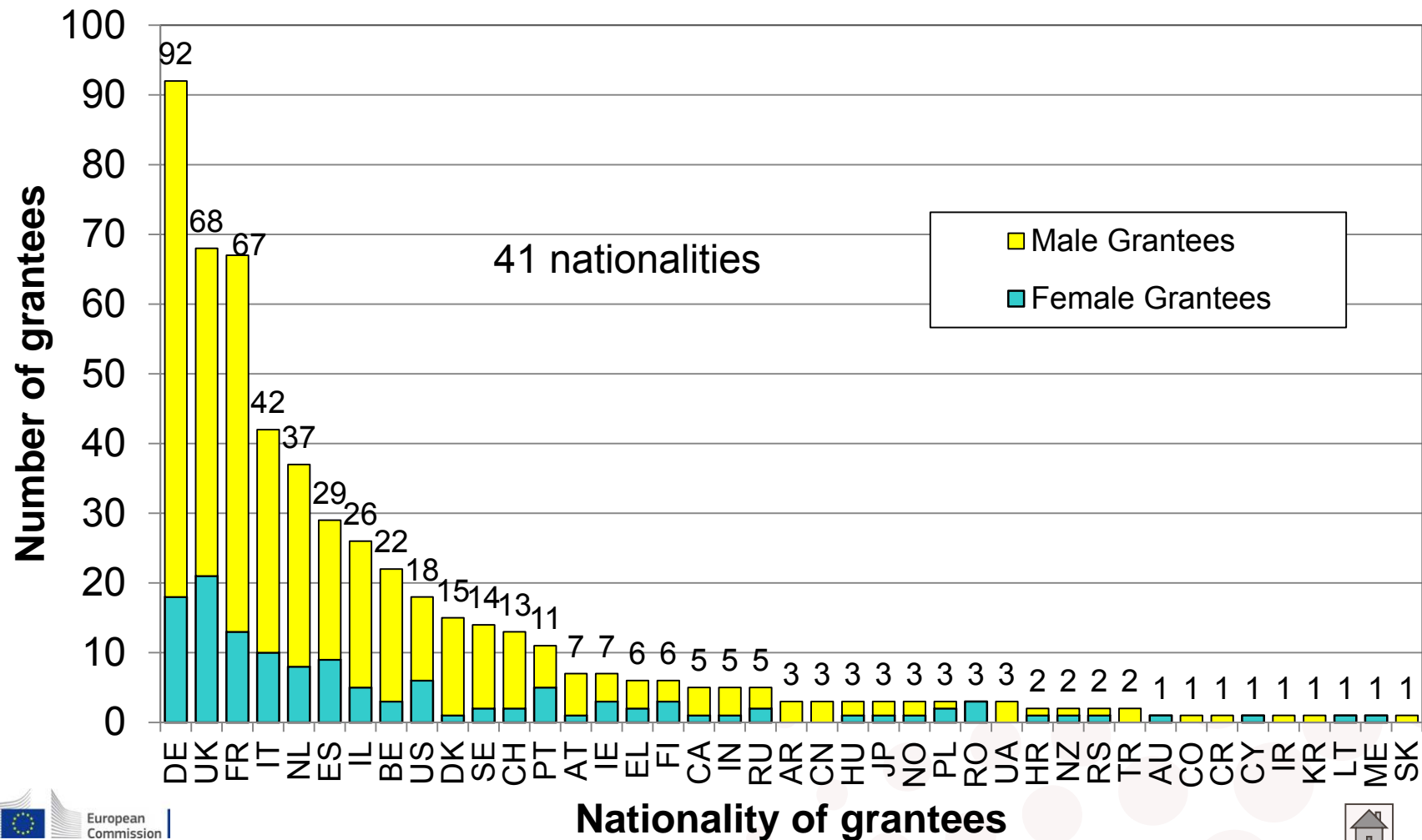

Grantees by nationality and gender

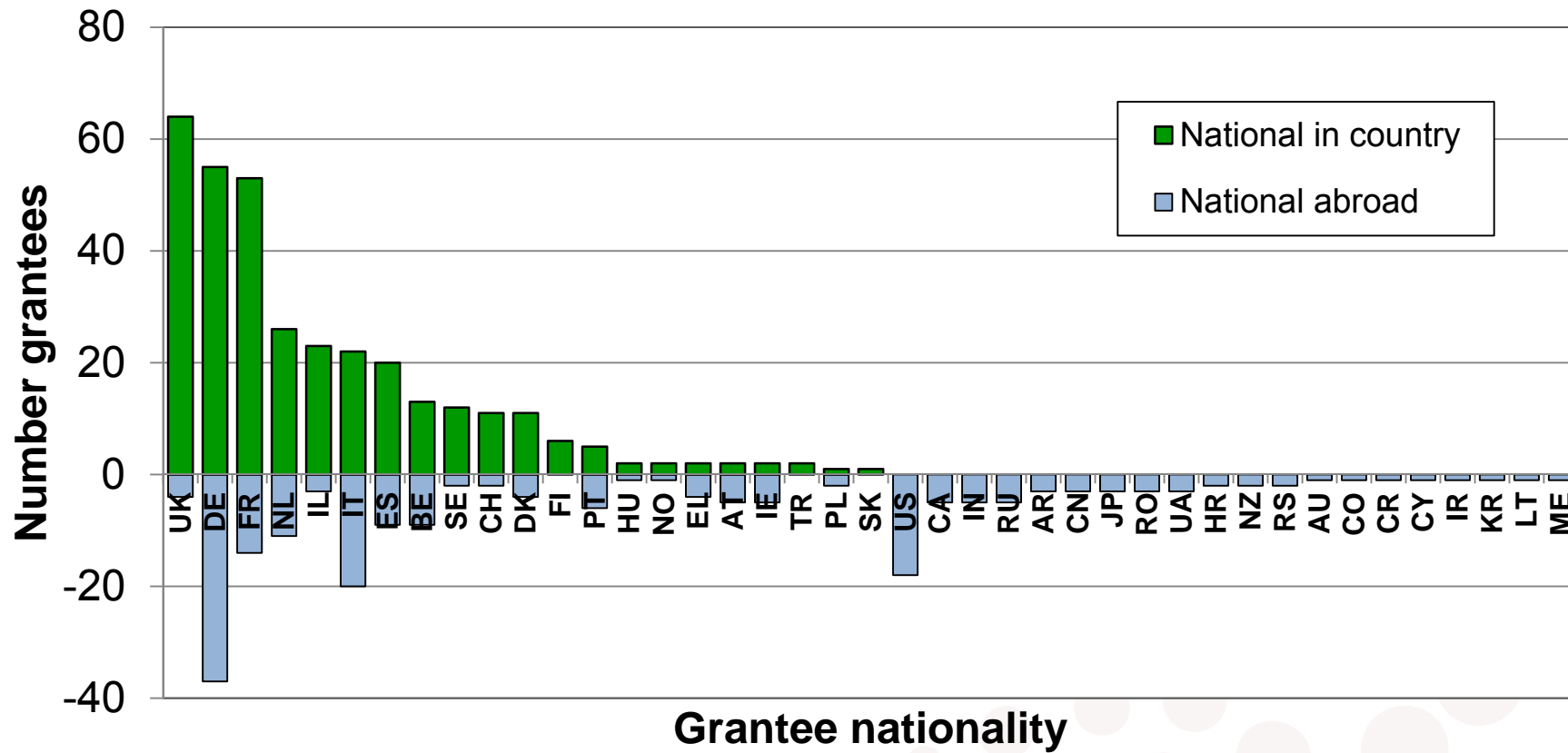

Nationals in own country and abroad

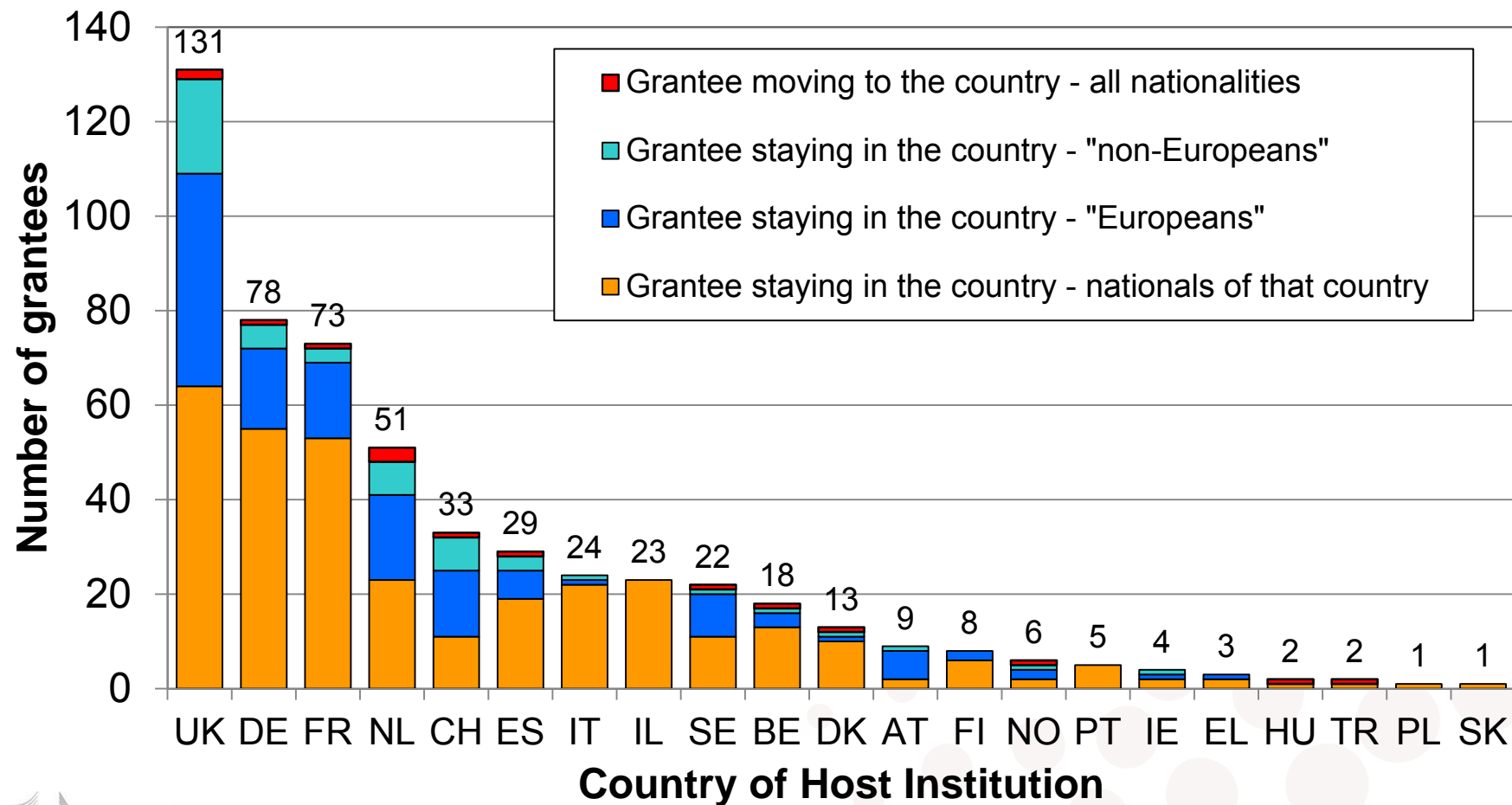

Mobility: Incoming and staying grantees

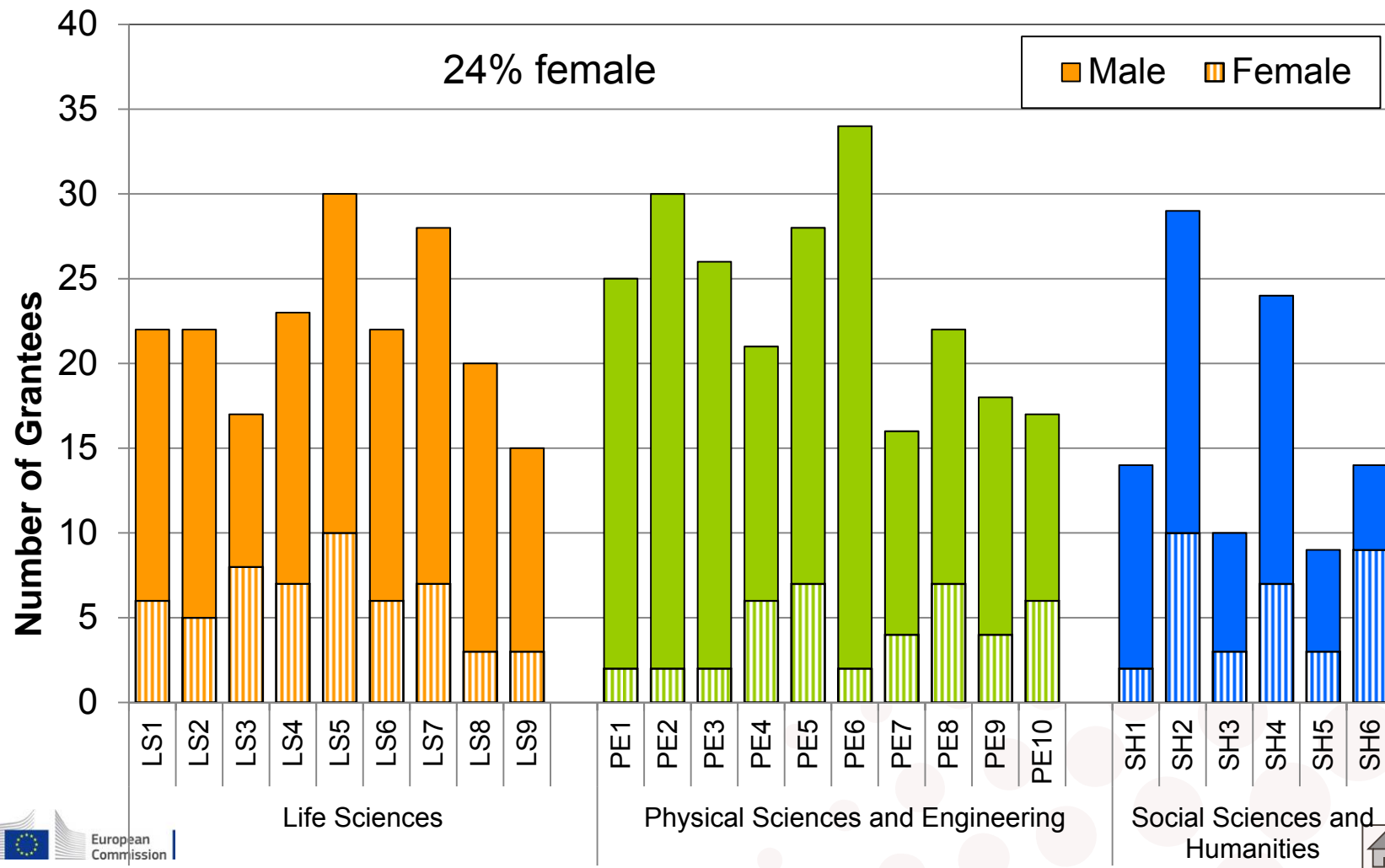
